**Application for the Exemption of Real Estate Tax**

Under the provisions of law, any person (including taxing districts) aggrieved by any assessment and desiring to appeal, shall file a statement, in writing, with the Board of Assessment Appeals on or before September 1. Such statement shall designate the assessment appealed from and the address to whom the Board shall mail notice of when and where to appear for a hearing. NO APPEAL SHALL BE HEARD BY THE BOARD UNLESS APPELLANT SHALL FIRST HAVE FILED THE APPEAL AND REQUIRED DOCUMENTS ON OR BEFORE SEPTEMBER 1, AS SET FORTH BY LAW.
