This plan is required due to these three dams being considered High Hazard Dams. Paid from Landfill Escrow account.

- Approve lease amendment with the U.S. Dept. of Veterans Affairs, extending the lease for the Veterans' Affairs clinic on Shumway Hill Road through 7/31/2026.
