Sheriff's Deputy – Full-Time

The **Tioga County Sheriff's Office** is currently accepting applications for the position of **Sheriff's Deputy**. This role offers a unique opportunity to serve both the Sheriff's Office and our local school communities through a combination of school-based and traditional law enforcement duties.

Primary Assignment – School Security Officer / School Resource Officer (SRO)

The successful applicant will begin as a **School Security Officer**, assigned primarily to district school buildings to ensure the safety and security of students, staff, and visitors. After completing all **Commonwealth of Pennsylvania–required certifications and training**, the Deputy will transition to the role of **School Resource Officer (SRO)**.

As an SRO, responsibilities will include:

- Maintaining a visible, positive law enforcement presence within assigned schools.
- Building rapport with students, faculty, and staff to foster a safe and supportive environment.
- Working in partnership with school administrators to address safety concerns, emergency planning, crime prevention, and youth-related issues.
- Serving as a mentor, informal counselor, and educator when appropriate.
- Responding to incidents on school property and coordinating with school officials during crises.

Secondary Duties

Outside of school operations, the Sheriff's Deputy will perform a wide range of traditional law enforcement tasks, including but not limited to:

- **Courthouse Security** – Providing safety and order within courtrooms and county facilities.
- **Prisoner Transport** – Safely transporting inmates to and from various facilities and court appearances.
- **Warrant Service** – Executing arrest warrants and conducting follow-up investigations.
- **Civil Process Service** – Serving civil documents such as writs, subpoenas, and Protection From Abuse orders.
- **Patrol Duties** – Supporting countywide patrol and responding to calls for service.
- Additional duties as assigned to support the mission of the Sheriff's Office.

Minimum Qualifications

- Must be **21 years of age** or older.
- High school diploma or equivalent.
- Valid Pennsylvania driver's license.
- Ability to pass a background investigation, psychological evaluation, and medical/drug screening.
- Ability to meet physical fitness standards required for Deputy Sheriff training.
- Prior law enforcement, security, military, or corrections experience is preferred but not required.

Preferred Qualifications

- Completion of **Act 2 Deputy Sheriff Training, Act 120**, or equivalent recognized law enforcement academy training.
- Experience working with youth or within educational environments.
- Strong interpersonal communication skills and the ability to de-escalate tense situations.
- Familiarity with Pennsylvania school safety laws and NASRO-aligned SRO training standards (or willingness to obtain).

Compensation & Benefits

- Competitive salary commensurate with qualifications.
- Uniforms and equipment provided.
- Training and professional development opportunities (including School Resource Officer certification).
- Health, retirement, and other county-offered benefits.

Interested candidates may submit a completed **Tioga County Employment Application**, résumé, and any relevant certifications to the Tioga County Sheriff's Office.

Applications may be delivered in person or emailed to the County Human Resources Department.
