Call to Order: Marc Rice (acting Chair) called the meeting to order at 6:30 p.m.

Roll Call: The roll call found four (4) members present: Erick Coolidge, Commissioner Marc Rice, Nancy Smith, and Kevin Connelly. Also, in attendance Kaye Aumick; Administrative Director and Rachel Courtney; Planning Director. Commissioners: Shane Nickerson and Sam Van Loon. Public in attendance: See attached.

Approval of Minutes: The November minutes were not approved as we did not have a quorum.

Old Business: Kaye gave the following updates:

- **Mountain Laurel Recovery Center – Westfield Borough** – The final plans are expected to be delivered on Friday 12/12 for signature and recording.
- **Morris Run Water Treatment – Acid Mine Reduction** – Nothing new. They are looking to present to the planning commission in either January or February. They are working to put together the plans and application paperwork.
- **Kecks Food Service – Jackson Township** – Nothing new. The construction is approximately 75% complete.
- **Croft Hollow Compressor Station** – They are in construction phase. Kaye will reach out in a project update.

Other Business:

- **Data Center Ordinance** – The ordinance was approved for adoption at the Board of Commissioners meeting on December 9. A 30-day public comment period is now open. Please provide your comments/feedback to Kaye Aumick or Rachel Courtney. All comments will be reviewed by the planning commission and a potential amendment of the ordinance will be approved at the Board of Commissioners meeting in March.
- **County Solar Ordinance (Amendments)** – The ordinance as amended was approved for adoption at the Board of Commissioners meeting on December 9.
- **Term Reappointments** – Marc Rice, Carol Hoke, and Bill Roosa's terms were approved by the Board of Commissioners at their December 9 meeting. The terms are for another 3 years.

Directors Report: Kaye gave a verbal report.

Data Center Presentation: Rachel Courtney; Planning Director provided a presentation on the planning commission talking about what we can do and what we cannot do relative to land use. Josh Zeyn gave information on the potential tax impacts of data center developments. Kevin Connelly; Planning Commission member spoke of the five key points of the data center ordinance. These being: lighting on and around the

buildings, sound and vibration, water consumption (closed loop system), electricity, and the buffering/fencing around the entire data center complex.
