VANDERHOOF FARM 100TH ANNIVERSARY

WHEREAS, as of the 2017 United States Census of Agriculture, Pennsylvania currently has 53,157 farms averaging 137 acres in size and a total land area of 7,278,668 acres. Of that number, there are 1,972 Century Farms, 189 Bi-centennial Farms, and 1 Tri-centennial Farm. In Tioga County, there are 104 Century Farms; and

WHEREAS, the Vanderhoof Farm, consisting of 200 acres in the Borough of Wellsboro and Delmar Township, has recently received Century Farm designation from the Pennsylvania Department of Agriculture; and

WHEREAS, when Everitt Vanderhoof's parents, Clyde and Hazel Vanderhoof, purchased the farm on March 15, 1919, they started with a small number of Holstein dairy cows to supply their family. From there, calves were purchased to raise and sell as bred heifers; and

WHEREAS, corn, oats, and hay were planted to be used on the farm, with the excess being sold. Everitt and his father also trucked farm equipment in the 40's and 50's, along with the regular crops, and purchased and sold cattle; all adding to the farm's income. Everitt became a multi-faceted dealer, selling "Smoker" equipment and elevators, "Grove" silage wagons and dump truck bodies, as well Dobler seed corn; and

WHEREAS, there have been five generations that have worked the farm. Everitt Vanderhoof, second owner of the family farm, still helps on the farm with assistance from his children, grandsons and great-grandsons; and

NOW THEREFORE, the Tioga County Board of Commissioners congratulates the Vanderhoof family on their Century Farm designation. This is a celebration of agriculture and family, by passing down farming as a way of life from generation to generation.
