WC Eshenaur – Split HVAC system at Highland Choc A motion was made by Roger C. Bunn, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve a proposal from W.C. Eshenaur & Son for additional HVAC units at the Highland Chocolates Factory. Due to extra machinery brought into the factory, the current HVAC cannot keep the temperature regulated - \$9,738. Act 13.

GR Noto – power feed for HVAC at HC A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve a proposal from G. R. Noto Electrical Construction to install sign lighting and provide electrical power feed for a split unit HVAC system at the Highland Chocolate Factory - \$7,230. Act 13.

Delta Develop. agreement

A motion was made by Roger C. Bunn, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve the renewal of a two-year consultant agreement with Delta Development Group for grant compliance, technical assistance and direct communication with state and federal officials and agencies for the Marsh Creek Greenway project and other County initiatives - \$4,693/month. Bunn and unanimously carried upon vote of three ayes and no nays to approve an amendment to an agreement with EADS Architects, for professional services for the Veterans Affairs building additional and renovations project – due to additional requests by the Bath VA - \$48,250. Act 13. Expense will be reimbursed by the Bath VA.
