NOW THEREFORE, BE IT RESOLVED, that Tioga County stands ready to work with the County Commissioners Association of Pennsylvania and counties throughout the commonwealth in support of these priorities for 2018;

RESOLVED, that these priorities emphasize the important role Tioga County plays to deliver services and to improve our communities and the well-being of our residents; and

RESOLVED, that Tioga County calls upon the General Assembly and the Administration to re-engage in dialogue on the appropriate level of partnership between the state and counties by reexamining and where necessary, reconfiguring the state-county financial and regulatory relationship; and
