- Tashner Wetland Mitigation and Stream Restoration Project The project was discussed and it was decided that the board will wait to hear from the state before making a decision to approve or deny.
- 2024 Rankings The rankings were reviewed with some discussion on the top 5 farms. Motion was made by Sam Wilson to accept the rankings, second by Bill Plummer. Motion carried by roll call vote with 6 yes votes. The rankings will now be sent to all applicants with a 30-day comment period open.
