## Resolution of the County of Tioga R-15-25

Addressing the Consequences of Missed Commonwealth Budget Deadlines

WHEREAS, the counties, school districts, and municipalities of Pennsylvania consistently meet their financial deadlines each year, demonstrating fiscal responsibility and commitment to those they serve; and

WHEREAS, since 2003, the Commonwealth of Pennsylvania has missed 15 budget deadlines, creating repeated uncertainty and disruption for counties and taxpayers alike; and

WHEREAS, Tioga County, like other counties across the Commonwealth, has been forced to use all available resources to continue operations during these delays; and

WHEREAS, the failure of the Governor and Legislature to enact a balanced budget on schedule places an unfair burden on counties; and

WHEREAS, the Pennsylvania House and Senate recessed as of July 1st, leaving counties to guess the entire 12 months of the Commonwealth budget for 2026. The County of Tioga strongly urges members of both chambers to return to session, and collaborate in good faith to serve the taxpayers and counties they represent; and

WHEREAS, the current cycle of gridlock and inaction is detrimental to the welfare of Pennsylvania residents and communities;

**NOW, THEREFORE, BE IT RESOLVED,** that the County of Tioga urges the Governor and the Legislature of Pennsylvania to prioritize their responsibilities, work collaboratively, and finalize a balanced budget without further delay; and

**BE IT FURTHER RESOLVED,** that the Governor and the Legislature should not adjourn until a balanced budget is enacted, ensuring fiscal stability for counties and protecting taxpayers from undue financial strain.
